Workshop Registration

Refund Policy – Read This Carefully

Training Materials

A link and password to download and open the training manual will be sent approximately 5 days prior to the first day of class. This is not hands on training; hands on training is when you actually perform your tasks. Training is primarily narrative. It's the only way to build your foundation before you begin.

What to Expect

A hardcopy of the training manual is provided – no need for you to print it out before class. But, we will work off of the computer primarily. Although some security will be provided during training and breaks, neither Atex Freight Broker Training, Inc. nor the hotel assumes any liability for loss or damage. During class, on the third day, if applicable and if we have time, we'll use all the computers to search for potential customers and make some actual phone calls.
